# **Service Officer Letter:**

Thanks for having me back and for all your support as well. If you haven't heard, the VA has opened the door to more of Blue Water Navy vets of the Vietnam campaign. This would be as victims of Agent Orange, the gift that keeps on killing. My regret is that we have already lost sailors and Marines in the interim. Now, a number of claims must be reconsidered and new claims will surely be filed. My advice: if you qualify don't wait, get your claim moving. I am working with several veterans who have not filed for their service dates of the late sixties and early seventies. How can we blame the VA for dragging their feet when troops still do the same? If you enjoy history lessons on YouTube, just search for VA related videos. The treatment many of us were subjected to is really criminal.

Oakland County Veteran Services has some of the best qualified staff of any I've had the pleasure of meeting and working with. At 1200 Telegraph Rd., Building 26E, 2<sup>nd</sup> Floor, these counselors are anxious to be of service to you. Remember, they may not know your individual story, so they will have to ask questions; all of which help them plan out just what sort of claim you can convince the Veterans Administration of granting.

I am a Board member of the Oakland County Veterans Relief Fund. When a veteran is in need of emergency assistance, financially, he or she should see one of these counselors. They can approve a Meijers Store purchasing card of up to \$100.00 dollars. A check would be issued for you to take and purchase that card in their service department. The Office Manager can approve up to \$200.00 dollars. Any amount above that, say for a utility bill, etc., has to go before the Board. We meet on the 3<sup>rd</sup> Tuesday of each month to review the applications. It is our job to see that the requests are legitimate and helpful. We cannot tolerate abuse of the system as our budget also covers burial flags, headstones, etc.

All that being said, I can tell you volunteering to work with fellow veterans is one of the most rewarding experiences of my life. I hope our youngest Post members catch this bug and when possible, step up and ask to serve as well. Even being able to drive a veteran to a doctor's appointment is a rush.

Best wishes to all the newly elected Post Officers, you stand strong where we need you.


